#### **OPTION 1** – Scorecard Inquiry

# 1. Confirm your Qualification




### Please confirm your Company's Qualification

If you notice discrepancies with your industry, location or size, please let us know right away as this will directly impact your assessment and needs to be dealt with **first**.

If your questions are primarily about why documents were rejected for some options, we **strongly** recommend submitting a <u>scorecard inquiry</u>, which is free of charge. This approach is best because option rejections typically allow for limited discussion in a live session, whereas the scorecard inquiry service provides comprehensive written guidance.
